

# EXTENSION REQUEST AGREEMENT



E&M Tax Services does not file extensions automatically, to request an extension, we will need the following information and request for **each** individual and entity requesting an extension.

There is a **non-refundable \$100 fee** that is due prior to filing your extension, which will be treated as a deposit towards your 2024 tax preparation fee.

The deadlines to file an extension are as follows:

1. Partnerships and Corporations – **extension request due to E&M by March 3<sup>rd</sup>, 2024**
  - Extended tax returns are due by September 15, 2024.
2. Individuals – **extension request due to E&M by April 01, 2024**
  - Extended tax returns are due by October 15, 2024.

An extension of time to file your return **DOES NOT** grant you an extension of time to pay your taxes. Estimated taxes should be paid by your regular deadline to help avoid penalties.

**E&M will provide an estimated extension payment to avoid penalties, to do so, we will need as much tax information as you have at this time. Below are examples of what we will need to provide an accurate extension payment.**

- All tax documents (W2s, 1099s, 1098s, etc.)
- Any major deductions you will have (Dependents, Sale of Property, Solar, etc.)
- Did you make any Estimated Tax Payments for 2024? If so, when, and how much?
- Changes: Married, Divorced, Kids, New House, etc.
- Estimated Income and Expenses of your business.

## **State Extensions:**

States have their own extension procedures, if you have worked in a state other than your resident state listed above. Please list all states you have worked in and how much you made in the respective state.
